To fund this service these past 2 years we received donations from private citizens in 2011, and funding from the Walmart Foundation for service we are providing in 2012. Walmart's grant regulations prevent us from applying for further funding in 2013. Many of our private donors in 2011 indicated that their donation was intended to be a one-time contribution and we don't feel that it would be fair to repeatedly solicit 50 individuals for a service that benefits a community of 60,000. We were extremely pleased that legislative action clarified that the spending of state Turnback money on programs such as ours is an appropriate use of these funds. We are asking that the City of Conway consider our request for \$55,000 in transportation funding for 2013.

For the fiscal year ending June 30, 2012 we provided 7,732 trips to Conway citizens age 60 and older to "life necessary" destinations such as medical appointments, human service agencies, grocery stores, etc. This total does not include transporting them to the Conway Senior Citizens Center or any recreational trips. These "life necessary" trips, for which we seek funding, currently cost an average of \$7.60 per trip.

We continue to utilize our other transportation funding sources (federal, state, United Way, donations, and fundraising) to transport senior adults to and from senior centers, and to provide transportation in rural areas. We use City of Conway funding specifically to support the transportation we provide elderly citizens on an individual basis within the City of Conway to dialysis, chemotherapy, medical and dental appointments, physical rehabilitation, human service agencies, grocery stores, etc. which is by far the most costly yet critical service we provide. Approximately 17% of this transportation involves senior citizens in wheel chairs requiring a vehicle equipped with a lift. Although we accept donations, no fees are charged for this service, or any of our services, so that the services we provide are not cost prohibitive to anyone.

In the absence of providing public transportation itself, the City of Conway has historically provided support to our organization for making this service available to all of its citizens age 60 and older. This is just one of many examples of what separates Conway from so many other communities, large and small, with regard to being a community that cares about, and cares for, its dependent citizens. It takes so little and means so much. We deeply appreciate your commitment to those who depend upon these services and we thank you for your consideration and support.
