ORDINANCE NO. O-07_____

AN ORDINANCE PROVIDING FOR RESTRICTIONS ON NOVELTY LIGHTERS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, The City Council for the City of Conway, Arkansas, meeting in regular session, finds that:

WHEREAS, juvenile fire setting has been identified as a fast growing fire threat in the United States; and

WHEREAS, novelty lighters have features which are attractive to children, including visual effects, flashing lights, musical sounds and toy-like designs, exemplars of which have been shown to the Conway City Council; and

WHEREAS, the Consumer Product Safety Commission has recalled thousands of novelty lighters since 1996 due to the danger posed to public safety; and

WHEREAS, functions of novelty lighters can be achieved without posing a danger to public health and safety; and

WHEREAS, many public safety agencies support the prohibition of the sale and distribution of novelty lighters; the National Fire Protection Agency, National Volunteer Fire Council, Western Fire Chiefs Association, the National Association of State Fire Marshals, and the Conway Fire Department have lent their support to this issue; and

WHEREAS, the Conway City Council finds that the dangers posed by these novelty lighters is a grave threat to the health, safety and welfare of the citizens of the City of Conway and further finds that an emergency exists necessitating the immediate adoption of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS:

Section 1. The Code of the General Ordinances of the City of Conway, Arkansas, is hereby amended by adding a section to be numbered 11.12.09, which said section reads as follows:

"11.12.09 Novelty Lighters.

- A. <u>Prohibitions; Inapplicability</u>. The retail sale, offer of retail sale, gift or distribution of any novelty lighter within the territorial jurisdiction of the City of Conway is prohibited. The prohibition is inapplicable to: (1) novelty lighters which are only being actively transported through the city; or (2) novelty lighters located in a warehouse closed to the public for purposes of retail sales.
- B. <u>Definition</u>. "Novelty lighter" means a lighter that has entertaining audio or visual effect, or that depicts, through the use of logos, decals, art work, or by other means, or that resembles in physical form or function articles commonly recognized as appealing to or intended for use by children ten (10) years of age or younger. This includes, but is not limited to, lighters that depict or resemble cartoon characters, toys, guns, watches, musical instruments, vehicles, toy animals, food or beverages, or that play musical notes or have flashing lights or other entertaining features. A novelty lighter may operate on any fuel, including butane or liquid fuel.
- C. <u>Exceptions</u>. The term "novelty lighter" excludes: (1) any lighter manufactured prior to 1980; and (2) any lighter which lacks fuel; or (3) any lighter which lacks a device necessary to produce combustion or a flame.
- D. <u>Enforcement</u>. The provisions of this section shall be enforced by the fire marshal, any police officer, any code enforcement officer, and any other City official authorized to enforce any provision of the City of Conway Municipal Code.
- E. <u>Violation; Penalty</u>. Any person or entity violating any provision of this section is guilty of an infraction, and upon conviction therefore, shall be subject to a fine or penalty of not less that \$25.00 nor more than \$500.00.

Section 2. The provisions of this ordinance are separable and, upon any finding that any provision of this ordinance is unenforceable, the remaining provisions shall be enforceable according to their terms.

Section 3. All ordinances, resolutions or other acts of the City in conflict with the terms hereof are repealed to the extent of any such conflict.

Section 4. The Conway City Council has determined that an emergency exists and that the immediate adoption and enforcement of this ordinance being necessary for the public peace, health, safety and welfare, the provisions hereof shall be in full force and effect from and after its passage.

AN ORDINANCE AMENDING SECTIONS 8.12.09 and 8.12.10 OF THE CONWAY MUNICIPAL CODE RELATING TO "TWO-HOUR" PARKING; REPEALING ANY ORDINANCES IN CONFLICT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Mayor and City Council desire to amend the Conway Municipal Code relating to "two-hour" parking, with the addition of "thirty minute" parking.

WHEREAS, previous ordinances and changes to the Conway Municipal Code relating to "thirty minute" parking require revisions to clarify penalty provisions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS, THAT:

SECTION 1. That Section 8.12.09 of the Conway Municipal Code is hereby amended to read as follows (deletions struck through with additions in italics):

8.12.09 Two hour pParking zones The street department is hereby authorized to determine the location of two hour *certain* parking zones and to maintain appropriate curb painting or lettering reasonably indicating the same, provided that the installation of such zones shall be subject to the following conditions:

A. All so called "two hour" zones heretofore designated and marked are designated as two hour parking zones.

 - b. No person shall park any vehicle in any two hour parking zone located in the city for longer than two (2) hours at any time between the hours of 8:00 a.m. and 6:00 p.m. If the hours are not designated, then not longer than two (2) hours at any time except on Sundays and holidays. All such two hour parking zones shall be designated by appropriate curb painting or lettering which reasonably conveys the location of such zones.
- B. No person shall park any vehicle in any two hour parking zone located in the city for longer than two (2) hours at any time between the hours of 6:00 a.m. and 6:00 p.m. If the hours are not designated, then not longer than two (2) hours at any time except on Sundays and holidays. All such two hour parking zones shall be designated by appropriate curb painting or lettering which reasonably conveys the location of such zones.
- B. *Thirty minute parking zones*

- a. All so-called "thirty minute" zones heretofore designated and marked are designated as thirty minute parking zones.
- b. No person shall park any vehicle in any thirty minute parking zone located in the city for longer than thirty (30) minutes at any time between the hours of 8:00 a.m. and 6:00 p.m. If the hours are not designated, then not longer than two (2) hours at any time except on Sundays and holidays. All such thirty minute parking zones shall be designated by appropriate curb painting or lettering which reasonably conveys the location of such zones.

SECTION 2. That Section 8.12.10 is hereby amended to read as follows (deletions struck through with additions in italics):

8.12.10 Penalty Any person not in compliance with this section shall be guilty of a violation. The penalty for violations in "two hour" zone parking areas *zones* shall be \$5.00 if paid on or before the court appearance date on the citation. A curb citation shall be provided in the issuance of a violation citation for the convenience of motorists. If the citation is not paid on or before the court appearance date or is contested in District Court, a violator is subject to court costs of \$25.00 in addition to the fine pursuant to Arkansas Code Annotated §§16-10-305 (a)(-5)(4)."

SECTION 3. That any ordinances in conflict herewith are hereby repealed to the extent of that conflict.

SECTION 4. That this ordinance is necessary for the protection of the peace, health and safety of the citizens of Conway, and therefore, an emergency is declared to exist, and this ordinance shall go into effect from and after its passage and approval.

The City Council hereby authorizes the Mayor and City Clerk to execute an amendment 21 to the existing interlocal agreement for MEMS Ambulance Service with the City of Little Rock, 22 Arkansas to provide for payment by Conway of a subsidy of \$91,531 to MEMS to cover 2008 costs for 23 the Conway service area. 24 Section 2. Severability. METROPOLITAN EMERGENCY MEDICAL SERVICES INTERLOCAL AGREEMENT

THIS AGREEMENT is made by and between the CITY OF LITTLE ROCK, ARKANSAS ("Little Rock"), and the CITY OF CONWAY, ARKANSAS ("Conway"), cities of the first class.

WHEREAS, Little Rock and Conway have participated in an interlocal agreement for Metropolitan Emergency Medical Services ("MEMS") ambulance services since 2004; and

WHEREAS, MEMS has successfully provided emergency and non emergency ambulance service to the City of Conway for that time; and

WHEREAS, MEMS has received less and less Medicare reimbursement in the past several years, which has caused MEMS' operations in Conway to cost more than it receives in income from Conway; and

WHEREAS, The Little Rock Ambulance Authority ("LRAA") and the Joint Emergency Medical Services Commission ("JEMS") recommend that Conway subsidize MEMS for the deficit that MEMS incurs in Conway such that MEMS core operations do not subsidize its loss of income in Conway; and

WHEREAS, the Board of Directors of Little Rock and the City Council of Conway by ordinance or resolution have authorized the mayors of Little Rock and Conway to enter into this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements of Little Rock and Conway and on the terms and conditions set out herein, the interlocal agreement between the City of Little Rock and the City of Conway is hereby amended to add a new section: "16. SUBSIDY. The 2008 subsidy for the City of Conway is \$91,531, with subsequent

subsidy amounts to be recomputed annually."
