Ordinance Passed:

- O-18-44 Ordinance appropriating funds in the amount of \$29,500 from Advance GSE Corp (low bidder) for the purchase of an aircraft tug for the Airport Department. *Vote 7-0*
- O-18-45 Ordinance accepting and appropriating donation funds in the amount of \$356.43 for the Conway Tree Board for Arbor Day. *Vote 7-0*
- O-18-46 Ordinance to rezone property located along the north part of 2585 Donaghey Avenue from C-2 to MF-3. *Vote 7-0*
- O-18-47 Ordinance to rezone property located at the NW corner of the intersection of Stermer Road and County Cub Road from A-1 to S-1. *Vote 7-0*

- O-18-52 Ordinance to approve reclassification of a complex manager II to a facilities manager within the Parks & Recreation Department. *Vote 7-0*
