On this date the City Council of the City of Conway, Arkansas met in regular session. Resolutions Passed:

R-22-24 Resolution approving the Department of Agriculture grant award in the amount of \$8,000 for the Conway Tree Board for the Dave Ward Drive Interstate Beatification project. *Vote 7-0*

Ordinance Passed:

- O-22-47 Ordinance approving the rezoning of +66.87 acres located south of Nutters Chapel Road, East of Ridgedale Circle. *Vote 7-0*
- O-22-48 Ordinance appropriating insurance proceed funds in the amount of \$5,510 for the Parks and Recreation Department. *Vote 6-0 w/ Alderman Hawkins not present.*
- O-22-49 Ordinance appropriating funds in the amount of \$41,765 for the Parks and Recreation Department. *Vote 6-0 w/ Alderman Hawkins not present.*
- O-22-50 Ordinance appropriating reimbursement funds in the amount of \$33,159.25 for the Conway Police Department. *Vote 6-0 w/ Alderman Hawkins not present.*
- 0-22-51 Ordinance approving the waiving of the competitive bid process, and appropriating funds in the amount of \$58,000 for Sky Cop, appropriating funds in the amount of \$30,732.17 for fleet maintenance equipment, and appropriating funds in the amount of \$14,000 for SWAT ammunition for the Conway Police Department. *Vote 6-0 w/ Alderman Hawkins not present.*
- 0-22-52 Ordinance appropriating funds in the amount of \$66,500 for the Conway Emergency Operations Center. *Vote 6-0 w/ Alderman Hawkins not present.*

- Approved Conditional use permit to allow swimming pool sales and services in C-1 zoning district for property located at 611 Court St. *Vote 7-0*
