Present Zoning. R-2A (Two-Family Residential), Robinson Historic District.

Abutting Zoning. South/East/West: R-2A (Two-Family Residential), Robinson Historic District; North: R-1 (One-Family Residential), Robinson Historic District.

Lot Area. 0.17 acres ±.

Surrounding Area Structures. The property is located in the Robinson Historic District on the west side of Mitchell Street. Area structures consist of single family residences in contemporary, colonial revival, "Garrison" colonial revival, craftsman, and a mid-century church facility. The property rests within an area of highly detailed, prominent homes.

General Description of Property and Proposed Development. The applicant is proposing to add railings to an existing 1800 sf home built and approved in 2018. The railings would be added to the existing front porch and would be constructed of black metal.

New Construction. New construction shall maintain, not disrupt the existing pattern of surrounding historic buildings along the street by being similar.

The porch railings will be of a similar materials and scale to the surrounding neighborhood. The railings will not convey a false sense of historicity and will contribute to the contemporary nature of the structure in a neutral way.

Staff recommends approval of the new porch railings.
