On this date the City Council of the City of Conway, Arkansas met in regular session. - R-23-63 Resolution of a voluntary levy of <u>four-tenths (.4) mil</u> on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue the exclusive purpose of operating, and maintaining the <u>cemeteries</u> for the City of Conway. Vote 7-0
- R-23-64 Resolution of a levy of <u>four-tenths (.4) mill</u> on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a <u>Policeman's</u> <u>Pension and Relief Fund</u>. Vote 7-0
- R-23-65 Resolution of a levy of <u>four-tenths (.4) mill</u> on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for a <u>Fireman's</u> <u>Pension and Relief Fund</u>. Vote 7-0
- R-23-66 Resolution of a levy of <u>four-tenths (.4) mill</u> on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising special revenue for the Pension and Relief Fund for paid <u>Non-uniformed employees</u>. Vote 7-0

R-23-67 Resolution of a levy of <u>three (3.0) mill</u> on the dollar be made upon the assessed valuation of all taxable real estate and personal property tax for raising <u>General Fund Revenues</u>. Vote 7-0
