- O-20-54 Ordinance appropriating & accepting CARE ACT grant in the amount of \$69,000 awarded to the Conway Regional Airport. *Vote 8-0*
- O-20-55 Ordinance approving and appropriating funds in the amount of \$95,150 for professional services and utility improvement with Garver Inc. and Conway Corporation for Conway Regional Airport. *Vote 8-0*
- O-20-56 Ordinance approving the rules and regulations and minimum standards for the Conway Regional Airport. *Vote 8-0*
- O-20-57 Ordinance waving the competitive bid requirements for Temple Inc, Consolidated Traffic Controls Inc., RTC Manufacturing to purchase and repair traffic signal products for the Transportation Department. *Vote 8-0*
