On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting: Councilman Hawkins, Councilman Grimes, Councilman Spurgers, Councilwoman Mehl, Councilman Ledbetter, Councilman Hawks, Councilman Jones, and Councilwoman Isby. Councilwoman Isby made a motion to approve the minutes of the City Council meeting on November 25th as submitted. Councilwoman Mehl seconded the motion. The motion carried 8-0.

She said the first installment had been received but just today had received the second installment in the amount of \$19,472.50 which would bring the total amount to \$52,127.50 and asked that amount to be added to the total. She added that this is a full reimbursement grant with no matching funds. Councilman Hawkins made a motion to amend the Ordinance to reflect the total amount, and Councilwoman Mehl seconded it. The motion carried 8-0. Councilwoman Isby made a motion to adopt the Ordinance and Councilman Spurgers seconded it. Mayor Castleberry presented Item B1 to the Council. Andrew Thames told the Council that this is an appropriation of A&P funds in the amount of \$27,765.00 for lighting that Conway Corp did along Morningside Drive and the parking lot. Councilwoman Isby made a motion to adopt the Ordinance and Councilwoman Mehl seconded it. The Clerk called the roll with the following voting "Aye": Councilwoman Mehl, Councilman Ledbetter, Councilman Grimes, Councilman Hawks, Councilman Spurgers, Councilman Hawkins, Councilman Jones, and Councilwoman Isby. The Ordinance passed 8-0.

C. Finance

1. Ordinance approving the FY2026 Budget for the City of Conway

O-25-112

Mayor Castleberry presented Item C1. He told the Council that in 2025 the City has given employees a \$1,000 Christmas bonus, longevity pay to all City employees, incentive raises to the Fire Department as well as a 2% raise. He added that insurance premiums for employees will not

increase in 2026, and a 1% COLA raise has been budgeted. He said that Fire Department staff have been increased by 6, as well as 5 additional staff in other departments. He told there that a 3% growth in revenues has been projected in order to balance the budget. Tyler Winningham addressed the Council with an overview stating that the budget this year was challenging due to a number of reasons. He said that earlier in the year the City took out a loan to purchase a fire truck and upgrades to the 911 radio system. He added that the debt was divided between CFD and CEOC accordingly. He said that this is the first year for the 911 center to be the lone PSAP in Faulkner County which is a burden on the budget. He told them that the Community Center is still an unknown as it is not known what an entire year of operations looks like. He explained how these budget items were figured into the budget. He reminded them that another challenge this year has been slow sales tax growth. There was discussion among the Council about the new sales tax for public safety and streets and drainage which will begin adding revenue in April of 2026. There was discussion among the Council as to how the loan for the fire truck and 911 radio system could be paid off more quickly. It was confirmed that debt service on five year financing has to be paid for from the general fund. There was further discussion regarding budgeted numbers for City departments as well as future projects, sales tax and debt repayment. Councilwoman Isby made a motion to adopt the Ordinance with the emergency clause and Councilman Ledbetter seconded the motion. The motion carried 8-0. The Clerk called the roll with the following voting "Aye": Councilman Spurgers, Councilman Hawkins, Councilwoman Isby, Councilman Ledbetter, Councilman Jones, Councilwoman Mehl, Councilman Hawks, and Councilman Grimes. The Ordinance with the emergency clause passed 8-0.

Mayor Castleberry confirmed that this meeting would be the final for 2025. The December 23 meeting is cancelled.

**A RESOLUTION ADOPTING THE ORGANIZATIONAL RULES AND PROCEDURES FOR THE CONWAY,
ARKANSAS CITY COUNCIL FOR THE CALENDAR YEAR 2026**

Whereas, by state law, city councils are charged with organizing their proceedings and setting their rules; and

Whereas, City councils are tasked to set their organizational rules and procedures at the first business meeting every year; and

Whereas, the City is required by law to have a majority of the elected members of the City Council vote on a particular issue in order to adopt or approve a measure presented for consideration; and

Whereas, if a state of emergency due to a public health concern is granted, the City of Conway maintains the ability to provide electronic means which would permit a City Council Member to view a particular meeting as it is being held and also enable that Member to actively participate in the meeting despite the fact that they are not physically present in City Council Chambers, or such other location where a City Council meeting is being held; and

Whereas, the City would have the ability to broadcast/livestream City Council meetings so that the meetings may be viewed electronically without physical presence at the meeting, and have a method for the public to present comments on the agenda items without physically attending the meeting during this period.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF
CONWAY, ARKANSAS THAT:**

Section 1. The Conway City Council shall formally adopt the rules and procedures of its long standing traditions and its general adherence to Robert's Rules of Order as written in the Rules & Procedures for Conway City Council, January 13th, 2026.

Section 2. Special rules set forth in said Rules & Procedures for Conway City Council and regarding the conduct of City Council meetings during a pandemic emergency shall be included.

THE CONWAY CITY COUNCIL RULES AND PROCEDURES:

City Council Jurisdiction:

The City Council shall possess all legislative powers granted by state law to cities of the first class and other corporate powers of the city not prohibited in state law or by some ordinance of the City Council made in pursuance of the provisions therein and conferred on some officer of the city. [A.C.A. 14-43-502(a)]

The City Council shall have the management and control of finances and of all real and personal property belonging to the corporation. [A.C.A. 14-43-502(b)(1)]

City Council Meetings:

City Council meetings are always open to the public. [A.C.A. 14-43-502 (b)(2)(A)]

The City Council shall conduct regular business meetings at 6:00 pm in the City of Conway Council Chambers building located at 1111 Main Street on the second and fourth Tuesdays of each month. If the City Council meets in committee, it will start at 5:30 pm. The City Council, by majority vote may reschedule or cancel such meeting as it deems necessary on a meeting by meeting basis. [A.C.A. 14-43-502 (b)(2)(A)]

Special or emergency meetings of the City Council may be called by the Mayor or any three (3) alderman by signed submittal of the time and place of the scheduled meeting and its agenda to the Mayor or Office of the Mayor, City Clerk or Office of the City Clerk, or the City Attorney, or the Office of the City Attorney in a timely manner to fully comply with the two hour notification requirement [A.C.A. 25-19-106(6)(2)] for all media and the same notification of all elected city officials. The notification shall be deemed given when those to be notified have been contacted or when an attempt to contact them has been made at the proper time, by every means of instant communications they have submitted for notification purposes.

Agenda for City Council Meetings:

Agenda items shall consist of all items of city business needing city council approval, judgment, or review arising out of the city budget; city departments; City Council committees; city committees, boards, and commissions; and all city systems and processes submitted for the purpose of city council action according to the procedures herein described.

Agenda items may also be submitted by the Mayor or any Alderman following the procedures herein described for consideration at any city council meeting. Planning Commission items are automatically forwarded to the Office of the Mayor for inclusion on the agenda. Any City Council agenda item that is held in committee will automatically be heard at the next regularly scheduled meeting, unless a specific date is agreed upon by the City Council. If the date agreed upon is more than 45 days and if a notification procedure is attached to the item (e.g., Planning Commission, Historic District items), then the applicant may be required to use that same notification process to ensure the public is aware of the change of date for such items.

The Office of the Mayor prepares the agenda. All Agenda items for consideration at regular City Council meetings must be submitted to the Office of the Mayor by 12:00 pm, no later than seven days prior to the City Council meeting. Items may be submitted later with the Mayor's approval.

All items should be submitted electronically (if applicable) with all necessary documentation, including ordinances and/or resolutions.

The City Council may, by a non-debatable two-thirds majority vote, add an item of business to any regular, special, or emergency City Council meeting.

Preparation of the Agenda packet for each regular City Council meeting should be completed and the agenda published on the City's official website **at least three (3) days before a regular public meeting.**" Ark. Code Ann. § 25-19-106(b)(3)(B) (as amended by Act 505).

Conduct of the City Council Meeting:

The Mayor shall be the ex officio President of the City Council and shall preside at its meetings, regular and special. [A.C.A. 14-43-501 (b) (1) (A)]

A quorum is defined as a majority of all Council Members on the City Council.

The City Council may as necessary compel the attendance of absent members in such a manner and under such penalties as they think fit to prescribe [A.C.A. 14-43-501 (a)(2)(C)(ii)]

The Mayor shall have a vote to establish a quorum at any regular meeting of the City Council and when his or her vote is needed to pass any ordinance, by-law, resolution, order, or motion. [A.C.A. 14-43-501 (b) (1) (B)]

In the absence of the Mayor, Alderman Andy Hawkins is elected president pro tempore to preside in his absence. If Alderman Hawkins is unavailable to preside in the Mayor's absence, the aldermen present at the meeting shall elect a temporary president pro tempore to preside for that one meeting. [A.C.A. 14-403-501 (b) (2)]

Business shall be conducted by Robert's Rules of Order. However, it is to be understood that parliamentary procedure is not the goal. The goal is the respectful conduct of business in an equitable order. It is also understood that formal parliamentary procedure is not well known. Therefore, an informal form of procedure can be used, provided that equity and order are maintained. If a question of order arises or if so requested by an alderman, the Mayor may implement the formal parliamentary procedure.

A positive motion is encouraged to start the consideration of each business item.

Ordinances that are required by state law to be read at three separate council meetings before being considered for action shall be so read unless the various readings are waived by the Council. The Council can choose to waive any or all readings of an ordinance when it comes up on the agenda by a non-debatable two-thirds majority voice vote. [A.C.A. 14-55-202]

Ordinances shall require a roll call vote. Emergency clauses associated with ordinances shall require an undebatable separate roll call vote and a two-thirds majority approval. The City Clerk shall maintain a random roll call list of aldermen for each separate business item requiring a roll call vote (Ord. No. O-02-200).

Resolutions and all other motions of the Council may be approved by voice vote. A show of hands will be required on all non-unanimous votes to properly record the votes in the record.

Discussion and Citizen Commentary:

Debate on Agenda items appearing before the City Council is reserved for the City Council. Citizen commentary at council meetings is allowed in specific situations and under conditions allowed by the City Council herein described.

While the City Council generally wishes for public input and public participation and publishes its individual contact information through the City, this willingness does not constitute an unrestricted right to speak at meetings of the Council.

Petitioners and City Officials: Petitioners and city officials appearing before the City Council regarding items of business arising from the agenda or placed on the agenda are recognized by the Council as having a right to speak to their petition or report, subject to restriction thereof.

City Council members and the Mayor may ask questions from time to time from petitioners, city officials, or the public. Those questioned will be allowed to answer, subject to restrictions imposed.

General Citizenry: The City Council restricts citizen input at any regular or special meeting to germane commentary regarding items of business before the Council arising from the meeting agenda or the Council's placement of an item on the agenda.

Citizen commentary may only occur at such time as the item of business is before the Council and under consideration for action. It is the City Council's intention to allow public input in an informal format with due regard to the equity of allowing the various sides of issues to speak and, within reason, with due regard to the number of people wishing to address the Council.

The Mayor as ex-officio president of the Council, may allow citizen input on a per business item basis provided that individual speakers are recognized in turn, identify themselves for the record, and address the Council from a podium and/or position established for such. Unrecognized comments from the audience are prohibited. The City Council may at any time restrict such citizen input in any fashion, including, but not limited to, the length of individual comments, the total number of speakers, and/or the total time allotted for public input.

At all times, an open conversation with or within the audience is strongly discouraged. The redundancy of commentary is strongly discouraged. More than one speaker at a time is prohibited.

Non-Agenda Commentary: The City Council may suspend the rules of order and allow citizen input/commentary on matters not included on the agenda of the City Council meeting. Suspending the rules of order requires a non-debatable two-thirds majority vote.

Special Procedures During Pandemic Emergency:

If a public health emergency is declared by the State of Arkansas or the Federal Government, below are the procedures that the City of Conway City Council will maintain:

- (a) During the Pandemic Emergency, City Council Members are authorized to attend, speak, and vote using Zoom or other virtual electronic means of communication during City Council Meetings and Committee Meetings.
- (b) That a Council Member may appear by electronic means for the purpose of providing the requisite membership attendance for matters coming before the Council; provided that

- the Mayor, the City Clerk, and the City Attorney, or their designees, are physically present and located at the place where the Council Meeting is being held and conducted, and who confirm such electronic appearance by such Council Member upon roll call. Council Members appearing at meetings pursuant to this subsection shall be entitled to participate by electronic means in matters coming before the Council, including discussion, debate, and voting, as if they were physically present at such meeting.
- (c) During a public health emergency, the public is encouraged to watch the video broadcast or live-streaming Internet broadcast of the City Council meetings rather than physically attending.
 - (d) Members of the public may attend as set forth herein or as permitted by a plan approved by the Arkansas Department of Health for indoor gatherings.
 - (e) Any member of the public may comment on any item of business on the published agenda of the meeting by delivering a written comment (no longer than 200 words) to the City Clerk/Treasurer no later than 4:30 pm the day of the City Council meeting. These comments can be dropped off at the front desk of City Hall, 1111 Main Street, Suite 102. Electronic delivery to councilagenda@conwayarkanas.gov is encouraged. Written comments so delivered will be read at the meeting.

A RESOLUTION APPROVING THE FY2026 TRANSPORTATION SERVICE CONTRACTS FOR INDEPENDENT LIVING SERVICES, BOYS & GIRLS CLUB OF FAULKNER COUNTY, & FAULKNER COUNTY COUNCIL OF AGING TO PROVIDE TRANSPORTATION SERVICES WITHIN THE CITY OF CONWAY; AND FOR OTHER PURPOSES

Whereas, there is a need to support with funding different agencies that provide specific transportation throughout the City of Conway; and

Whereas, Independent Living Services, Boys & Girls Club of Faulkner County, & Faulkner County Council on Aging all provide a valuable service for the City that is beneficial for a wide variety of citizens throughout Conway.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS THAT:

**A RESOLUTION IN SUPPORT OF REVIVING THE STATE RUN FEDERAL SURPLUS PROPERTY PROGRAM,
ADMINISTERED BY THE STATE OF ARKANSAS, AND FOR OTHER PURPOSES**

Whereas, the City of Conway has directly benefited from this program in the past and recognizes its critical role in supporting local government operations; and

Whereas, the Arkansas Federal Surplus Property Program has historically provided cities, towns, counties, state agencies, fire departments, and non-profits across the state with access to high-quality, government-grade equipment and supplies at a fraction of retail cost; and

Whereas, the program enabled local governments to acquire essential items—such as vehicles, tools, office furniture, emergency response gear, and generators—at discounts of up to 90%, often paying only 5–10% of the original value; and

Whereas, the program was recently shut down due to a reported \$300,000 operating deficit, largely caused by changes in federal policy that shifted surplus property sales to online platforms, reducing the volume of high-value items available to the state; and

Whereas, despite this shortfall, local governments collectively paid approximately \$900,000 for surplus items through the program—receiving goods worth many times that amount—demonstrating the program’s high return on investment and value to Arkansas communities; and

Whereas, the closure of the program disproportionately affects small and rural municipalities that rely on affordable access to durable equipment to maintain public safety, infrastructure, and essential services; and

Whereas, the Arkansas Legislative Council’s Joint Performance Review Committee has heard testimony from local officials and emergency responders urging a fiscal impact study and reconsideration of the program’s closure.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CONWAY ARKANSAS:

Section 1. The City of Conway strongly supports the revival or replacement of the Arkansas Federal Surplus Property Program.

Section 2. That we urge the Governor, the Arkansas General Assembly, and relevant state agencies to explore sustainable funding models or partnerships to restore this vital service.

AN ORDINANCE TO ACCEPT AND ADOPT CHAPTER 8.82 OF THE MUNICIPAL CODE REGARDING THE USE AND OPERATION OF MOTORIZED E-SCOOTERS AND SCOOTER-SHARE PROGRAMS WITHIN THE CITY OF CONWAY, ARKANSAS

Whereas, the Arkansas General Assembly enacted Act 1015 of 2019, the Electric Motorized Scooter Act, which authorizes the deployment of electric scooters and scooter-share programs throughout the State of Arkansas; and

Whereas, the Electric Motorized Scooter Act does not allow cities to prohibit the operation of scooter-share programs but authorizes them to enact reasonable regulations; and

Whereas the Electric Motorized Scooter Act went into effect on July 24, 2019, and the City's regulations and permitting processes are expected to become effective on March 1, 2026.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CONWAY, ARKANSAS

Section 1: That these amendments to the Conway Municipal Code are hereby adopted by reference, and included as Exhibit "A" to this ordinance, as amended additions for Chapter 8.82, as amended and also known as the Conway Municipal Code.

Section 2: That any ordinances in conflict herewith are hereby repealed to the extent of the conflict. The Mayor and Council shall be empowered to codify the Conway Municipal Code as necessary to update the Code as specified.

Chapter 8.82

ELECTRIC SCOOTERS AND SCOOTER-SHARE SYSTEMS

8.82.1 Purpose.

The purpose of this chapter is to promote safe, orderly, and accessible use of electric scooters; to preserve pedestrian movement in the public right-of-way; and to establish permitting and operational regulations for scooter-share systems operating within the City.

8.82.2 Definitions.

For the purposes of this chapter, the following terms shall apply:

- A. **"Electric Scooter"** means a device weighing no more than one hundred (100) pounds, having two or three wheels, with handlebars and a standing deck, powered in whole or in part by an electric motor, and intended for use by a single rider.
- B. **"Scooter-Share System"** means a transportation service through which electric scooters are made available for short-term public use, whether through a dockless, station-based, or hybrid deployment model.
- C. **"Operator"** means any person, partnership, corporation, or entity owning, deploying, maintaining, or otherwise facilitating use of a scooter-share system.
- D. **"Public right-of-way"** means land or easements owned, dedicated, or controlled by the City for public travel, including sidewalks, streets, bike lanes, multi-use paths, parkways, and public easements.

8.82.3 Operation of Electric Scooters.

- A. **Permitted areas of operation.** Electric scooters may be operated:
 - 1. Within designated bicycle lanes.
 - 2. On streets with posted speed limits of thirty-five (35) miles per hour or less. While traveling slower than the normal flow of traffic, travel should be in the right-hand lane, with the exception of passing another vehicle, preparing for a left turn, avoiding hazards, narrow lanes, or approaching an intersection with a right-turn lane when not turning right.
 - 3. The rider is not required to ride over hazards or maintain a dangerously narrow right-side position; riding lawfully under this section does not constitute impeding traffic.
 - 4. Riders shall not attach the scooter or rider to any vehicle.
 - 5. Riders shall not carry any package, bundle, or article preventing them from keeping at least one hand on the handlebars.

- B. Sidewalk restriction.** Operation on sidewalks is prohibited except:
1. Where signage expressly authorizes sidewalk riding; or
 2. On multi-use pedestrian-bicycle facilities.
 3. When operating on a sidewalk, the rider must yield the right-of-way to pedestrians and must give an audible signal before passing a pedestrian.
 4. For operation within a pedestrian crosswalk, the rider must yield to vehicular traffic and pedestrians. To gain pedestrian protections, the rider must dismount and walk the scooter, obeying all traffic control devices.
 5. Riding on any sidewalk that abuts a building is prohibited.
- C. Speed limitations.**
1. Maximum speed on streets or multi-use paths shall not exceed fifteen (15) miles per hour.
 2. The maximum speed where sidewalk riding is authorized shall not exceed ten (10) miles per hour.
- D. Traffic compliance.** Riders must comply with all traffic laws applicable to bicycle users.
- E. Safety:**
1. Scooters must be equipped with a brake.
 2. For night operation, scooters must have a front white light, a rear red light, and a reflector. Lights must be visible from at least 500 feet under normal conditions.
 3. Lights must be visible from at least 500 feet under normal conditions. Lights must remain on for at least 90 seconds after the scooter stops.

8.82.4 Parking and Storage.

- A.** Electric scooters shall be parked upright and in a manner that does not:
1. Obstruct pedestrians.
 2. Block ADA-required clearances or curb ramps.
 3. Interfere with building entrances or driveways.
 4. Restrict access to transit stops or emergency facilities.
- B.** Scooters shall be parked within designated scooter parking areas where provided.
- C.** Scooters shall not be parked on city streets without express permission.
- D.** Scooters shall not be parked on private property unless the owner's permission has been obtained.
- E.** Scooters must not be parked within five feet of a crosswalk or curb ramp.
- F.** On multi-use trails, scooters may only be parked at trailheads or other areas designated by the City.
- G.** Scooters must stand upright while parked.
- H.** The Mayor, or designee, may designate restricted parking areas and associated signage.

- I. Operators must be 16 or older.

8.82.5 Scooter-Share Permit Required.

- A. No operator shall deploy or maintain a scooter-share system without first obtaining a permit issued pursuant to this chapter.
- B. Permits shall be valid for twelve (12) months unless suspended or revoked.
- C. The City of Conway may limit:
 - 1. Total number of permitted operators.
 - 2. Maximum fleet size.
 - 3. Deployment locations or operating zones.
 - 4. Permit will not authorize operation on any private property, College or University unless prior approval is obtained by the owner of said property.

8.82.6 Operator Requirements.

Each permitted operator shall:

- A. Maintain commercial liability insurance of not less than:
 - 1. One million dollars (\$1,000,000) per occurrence.
 - 2. Two million dollars (\$2,000,000) aggregate.
and name the City of Conway as an additional insured.
- B. Ensure scooters are safe, functional, and compliant with manufacturer specifications.
- C. Remove damaged or improperly parked scooters within two (2) hours of notification.
- D. Provide monthly data reports, including:
 - 1. Trip counts
 - 2. Fleet deployment totals
 - 3. Response times to complaints
 - 4. Number and nature of reported safety incidents.

Data must be aggregated and non-personally-identifying.

- E. Provide safety and parking instructions on each scooter and through any associated mobile application.
- F. Each shared scooter must clearly display the operator's emblem, customer support info (phone and website information), and a unique alphanumeric ID visible from 5 feet away and not covered by branding or other markings.
- G. Provide methods for users to rent without requiring a smartphone.
- H. Clearly and understandably communicate rates to customers before use.
- I. Educate users via the website or app about compliance with all general operation, parking, and safety rules.
- J. Each unit must have an on-board GPS or equivalent system for location tracking, recovery, data collection, and incident investigation.

- K. Scooters must be robust enough for outdoor storage and frequent use and must have tamper resistant security hardware.
- L. Motors for licensed shared scooters must be under 750 watts or one horsepower.
- M. Operators must have the ability to implement “no-ride zones,” slow-ride zones, and to enforce city-designated no-parking zones.
- N. Shared scooters must meet safety standards equivalent to those for bicycles under applicable federal and international standards.
- O. Operators must have processes in place for maintenance/safety: inspection on removal from service, a mechanism for users to report safety &/or maintenance concerns, and a mechanism for disabling units remotely.
- P. Unsafe scooters must be removed from service within four hours of notice and not redeployed until repaired.
- Q. Operators must respond to certain categories of public complaints/obstructions within defined time-frames, like sidewalk obstructions or other prohibited locations, within a one-hour time frame.
- R. Operators must have a battery recycling/disposal program that is compliant with federal hazardous waste regulations.

8.82.7 Fees.

- A. The annual permit fee for scooter-share operation shall be established by the City Council at a rate of a non-refundable fee of \$150 + \$20 per shared scooter. This permit will require an annual renewal.
- B. The City of Conway may impose a per-device right-of-way usage fee.
- C. Fees collected may be used for:
 - 1. Administration of this chapter.
 - 2. Maintenance and enforcement.
 - 3. Public safety and transportation infrastructure improvements.

8.82.8 Enforcement and Penalties.

- A. The Mayor, or designee, may impose any of the following enforcement actions:
 - 1. Issuance of written notice or administrative citation.
 - 2. Reduction of permitted fleet size.
 - 3. Temporary suspension of operations.
 - 4. Revocation of permit.
- B. Administrative penalties may include:
 - 1. Fifty dollars (\$50) per improperly parked scooter.
 - 2. One hundred dollars (\$100) per unsafe operation or verified service failure.
 - 3. Up to five hundred dollars (\$500) per day for unpermitted deployment.
- C. The City of Conway may impound any unpermitted or hazardous scooters.

8.82.9 Pilot Program Authorization.

- A. The City of Conway may issue temporary permits valid for up to twelve (12) months for evaluation purposes.
- B. During a pilot period, the City may modify:
 - 1. Fleet sizes
 - 2. Deployment boundaries
 - 3. Reporting requirements

8.82.10 Severability.

If any provision of this chapter is determined invalid, the remaining sections shall remain in full force and effect.

Charleston Place Sub was rezoned to R-1 in October of 2017. The Westlake Apartments property was rezoned to MF-2 in March of 1996. This is the only property, along with the 2 abutting southern properties, in this area which have never been rezoned or redeveloped since annexation.

Abutting land uses are single family subdivisions to the north and east, single family A-1 zoned lots to the south, and the Westlake Apartment development to the west. A childcare facility is located southwest. The Comprehensive Plan indicates the parcels as Single-Family. The requested zoning conforms.

The Planning Commission reviewed the request at its regular meeting on December 15, 2025, and voted 7-0 that the request be forwarded to the City Council with a recommendation for approval.
