On this date, the City Council of the City of Conway, Arkansas, met in regular session. The following members, being a quorum, were present and acting: *Councilman Hawkins, Councilman Grimes, Councilwoman Mehl, Councilman Ledbetter, Councilman Spurgers, and Councilwoman Isby*. Also, present and acting: *City Attorney Charles Finkenbinder, & City Clerk/Treasurer Denise Hurd*. *Mayor Castleberry, Councilman Jones & Councilman Hawks were not present.*

**Resolutions Passed:**

- R-26-08** Resolution approving the use of policies and procedures for the administration and implementation of the RAISE Grant for Connect Conway. **Vote 6-0**
- R-26-09** Resolution to approve the purchase of an articulated dump truck in the amount of \$693,702.00 for the Department of Sanitation.
- R-26-10** Resolution to approve the purchase of two refuse trucks (one side load, one rear load) in the amount of \$394,816.32 and \$279,165.53 for the Department of Sanitation.

- O-26-17** Ordinance approving the Private Club Permit location for Waldo's Conway dba: Waldo's Chicken at 2205 Dave Ward Drive. **Vote 6-0**
- O-26-18** Ordinance appropriating funds in the amount of \$498,584.53 and approving the purchase of two refuse trucks (one rear load and one roll off) in the amount of for the Department of Sanitation. **Vote 6-0**
- O-26-19** Ordinance appropriating reimbursement funds from various entities for the Conway Police Department. **Vote 6-0**
- O-26-20** Ordinance appropriating funds in the amount of \$88,371.61 for the purchase of ballistic plates for the Conway Police Department. **Vote 6-0**
