



ANNEXATION GUIDELINES & PROCEDURES

Established through state statute A.C.A § 14-38-101—108 and 14-38-114—116 and City of Conway Ordinance #O-22-77.

All areas to be annexed must be contiguous to and adjoin lands which are included within the City of Conway, Arkansas.

Procedure [1] - Voluntary Annexation (including non-voluntary owners)

A.C.A. § 14-40-601 (a) *"When a majority of the real estate owners of any part of a county contiguous to and joining any city or incorporated town desires to be annexed to the city or town, they may apply by attested petition in writing to the county court of the county in which the city or town is situated..."*

A.C.A. § 14-40-601 (b) *"The "majority of real estate owners" referred to in this section means a majority of the total number of real estate owners in the area affected if the majority of the total numbers of owners own more than one-half (1/2) of the acreage affected."*

1. The applicant shall file an attested petition with the County Court.
2. Upon filing, the Clerk shall set a public hearing date for the petition which shall not be less than thirty (30) days after the filing of the petition.
3. Following the filing of the petition, the applicant must place a notice of public hearing in the *Log Cabin Democrat* or *Arkansas Democrat-Gazette* appearing one (1) time per week for three (3) consecutive weeks.
4. Once approved at the hearing, the County Court issues an order granting the petition and releasing the property to be considered for annexation by the City.

OR

Procedure [2] - 100% Petition Annexation

A.C.A. § 14-40-609 (b)(1) *"Individuals who own property in a county that is contiguous to a city or town may petition the governing body of the city or town to annex the property that is contiguous to the city or town."*

1. The applicant must submit a petition, in writing, to the County and it shall include:
 - a. A notarized statement by the property owner(s) confirming the desire to be annexed;
 - b. An accurate legal description of the subject property;
 - c. A letter/title opinion from a certified abstractor/title company verifying the petitioners are all owners of record of the subject property;
 - d. A letter/verification from a certified surveyor or engineering verifying that the subject property is contiguous with the City of Conway boundary and that no enclaves/islands will be created if the subject property is accepted;
 - e. A schedule of services of the City of Conway which will be extended to the area within three (3) years after the date the annexation becomes final.
2. The complete petition shall be filed with County Assessor and the County Clerk.
 - a. Within fifteen (15) days of filing, the Faulkner County Assessor and Faulkner County Clerk shall verify that the petition meets the requirements and submit the petition to the County Judge for review;
 - b. Within fifteen (15) days of receipt, the County Judge shall review the petition and if all requirements are met, issue an order and forward the petition and order to the City of Conway.

For the convenience of the applicant, the City has followed the custom of allowing the applicant to submit the request for annexation to the City prior to completing the process with the County.

1. At the time the applicant submits the petition to the County, they may also submit the application requesting annexation to the Planning & Development Department in accordance with the Planning Commission calendar (attached).
2. The following items must be submitted:
 - A. A copy of the application requesting annexation
 - B. A non-refundable filing fee of \$325.00
 - C. A copy of the plat of the proposed annexation
 - 1) No property will be annexed before all current configurations of parcels within the area have been identified. Upon annexation, only those parcels that are in compliance with the Subdivision Ordinance of the City of Conway shall be eligible for the issuance of building permits
 - 2) In order to ascertain the configuration of existing parcels of property, all applications for annexation will include a map of the area, drawn to scale showing the parcels and their ownership. The map will include:
 - a. All subdivisions that have been approved by the Conway Planning Commission
 - b. All subdivisions that were properly filed prior to the creation of the Planning Commission
 - c. Any subdivisions that were created before the area was under the jurisdiction of the Conway Planning Commission
 - D. For parcels that are not part of a legal subdivision, copies of deeds dated prior to July 1, 1986 showing the parcel in its current configuration must be submitted. If no deeds are available, parcels must be created through a legal subdivision or it must be established through deeds that the parcel was created at a time when it was not within the territorial jurisdiction of the City of Conway or those parcels will not be eligible for the issuance of building permits
 - E. The legal description of the property proposed for annexation
3. The Planning Commission reviews the request for annexation and, if approved, makes a recommendation to the City Council that the property be accepted for annexation.
4. The City Council, if appropriate, adopts the ordinance annexing the property. If the order, by the County Court, granting the petition, is not available by the time the request for annexation is heard by the City Council, the City Council will, if appropriate, pass a resolution indicating the intent of the City to accept and annex the property when it is released by the County.
5. The ordinance accepting and annexing the property must be published one (1) time in the *Log Cabin Democrat*. The applicant will be billed by the City Clerk for the cost of the publication.
6. **STREETS** - No property will be annexed to the City of Conway before it has been established in the annexing ordinance which portions of which streets within the property will be accepted as public streets for maintenance and which streets will be recognized as public streets for the sole purpose of allowing the issuance of building permits. No section of a street will be accepted for public maintenance unless the appropriate right-of-way, based on the Master Street Plan, has been dedicated by the abutting property owners.

All annexed areas will be assigned an address that is in accordance with the City of Conway addressing system. 2-digit County addresses will be changed to 4-digit City addresses.

Note: This is not an exhaustive guideline regarding annexations. Appropriate state statutes, county, and city ordinances, and resolutions will provide additional information.

Checklist of Items for Annexation Application

- Application for Annexation** - filed with the Planning & Development Department in accordance with the Planning Commission calendar.
- Filing fee of \$325** - paid at the Planning & Development department in accordance with the Planning Commission calendar. Make checks payable to City of Conway.
- Plat of property annexation** - filed with the Planning & Development Department in accordance with the Planning Commission calendar.
- Legal description of the property to be annexed** - filed with the Planning & Development Department in accordance with the Planning Commission calendar.
- Identification of parcels** - filed with the Planning & Development Department in accordance with the Planning Commission calendar. Refer to 'Procedure' items 5.3 and 5.4.
- Copy of the Order [from the County Court] granting the petition** - Must be filed with the Planning and Development by eight (8) days prior to the date of City Council Meeting at which the ordinance will be considered.
