



# GUIDE TO SUBDIVISION REVIEW

Refer to this form for subdivision review application requirements. Applications are only accepted via the ONLINE APPLICATION PORTAL text. Please contact Planning & Development Staff for assistance.

### Types of Applications:

PRELIMINARY MAJOR PLAT APPROVAL (5 or more lots, minor subdivision incl. new streets/drainage, etc.)

MINOR SUBDIVISION (4 or fewer lots incl. NO new streets/drainage, lot merger, etc.)

MAJOR FINAL PLAT APPROVAL

POST-APPROVAL WAIVER/VARIANCE REQUEST (additional requests following Planning Commission approval)

PRELIMINARY PLAT APPROVAL EXTENSION (One 12-month extension allowed)

### For an application to be considered complete, the following information is required:

- All relevant contact information must be provided, including applicant, authorized agent, property owner(s), etc.
- A letter of applicant requesting review and approval of the submitted major subdivision (Upload as **Cover Letter**)
- Legal description (metes and bounds if no lot and block description exists)
- All relevant drawings (incl. plat, street and drainage plans, drainage report, etc.) must be complete and included.
- All applicable plat and engineering review fees must be paid in full. Refer to fee schedule for further details.
- A letter requesting any desired waivers to the requirements of the Subdivision Ordinance, including justification for each waiver request *citing regulation article and section*. (Upload as **Additional Supporting Documentation** and label *Request for Waiver*). Waivers requested following approval will incur the additional \$100 post approval review fee.

### Additional information:

- Recording fees are set by and paid by the applicant directly to the Faulkner County Circuit Clerk.
- If paying by check, plat review and engineering review fees must be paid separately.
